### **New Zealand Defence Force: Proposal to Nominate a Candidate for the Role of Multinational Force and Observers' Force Commander – Release of Cabinet Documents**

December 2019

This publication provides papers associated with Cabinet's July 2019 decision to agree to the New Zealand Defence Force nominating a candidate for the role of Force Commander to the Multinational Force and Observers' mission in the Sinai Peninsula in Egypt; and (if the New Zealand candidate is endorsed by the mission and the Egyptian government) to seek approval for the deployment of the Force Commander and a Military Assistant and Personal Protection Officer from December 2019 to March 2022.

### Role of Force Commander to the Multinational Force and Observers Mission: Proposal to Nominate a Candidate

**Portfolios** Foreign Affairs / Defence

On 23 July 2019, the Cabinet External Relations and Security Committee (ERS):

#### Background

- 1 **noted** that on 11 September 2018, ERS agreed to extend the 28-person mandate of the New Zealand Defence Force (NZDF) to the Multinational Force and Observers (MFO) mission in the Sinai Peninsula, Egypt, by two years, until September 2020 [ERS-18-MIN-0016];
- 2 **noted** that New Zealand has maintained a consistent presence in the MFO since 1982, and that the mission is an important contribution to regional peace and stability, the international rules-based order, and the promotion of New Zealand's values;

#### Proposed deployment

- 3 **noted** that New Zealand has received a request from the Director-General of the MFO to nominate a candidate as Force Commander;
- 4 **agreed** to the proposal of a NZDF nominee for the role of MFO Commander;
- 5 **noted** that New Zealand would provide an accompanying Personal Protection Officer and Military Assistant for the duration of the Force Commander's term;
- 6 **approved** the deployment of a Force Commander, Military Assistant, and Personal Protection Officer from December 2019 to March 2022, contingent on the requisite approvals from the mission and host governments;
- 7 **agreed** that the NZDF may temporarily exceed the Cabinet-mandated personnel numbers for New Zealand's MFO deployment for the purposes of command reconnaissance, rotation, and extraction of forces from theatre [CAB-18-MIN-0346];
- 8 **noted** that the overall unmitigated threat level for NZDF personnel deployed to the MFO is s6(a)
- 9 **noted** that deployed personnel receive regular and relevant training for the risk environment; and that the operational threat level is continually monitored by the NZDF;

**Financial implications**

- 10 **noted** that the total estimated cost of the proposed deployment from December 2019 to March 2022 is assessed as \$0.505 million;
- 11 **noted** that the estimated cost can be met from within the existing Vote Defence Force: Operations Contributing to New Zealand's Security, Stability and Interests MCA.

## PROPOSAL TO NOMINATE A CANDIDATE FOR THE ROLE OF MULTINATIONAL FORCE AND OBSERVERS' FORCE COMMANDER

### Proposal

1. To seek agreement for the New Zealand Defence Force (NZDF) to nominate a Force Commander to the Multinational Force and Observers' (MFO) mission in the Sinai Peninsula in Egypt; and (if the New Zealand candidate is endorsed by MFO Director-General and the Egyptian and Israeli Governments) to seek approval for the deployment of the Force Commander and two associated positions from 1 December 2019 to 31 March 2022.

### Background

2. On 10 July 2019, the Minister of Defence received a written request from the Director-General of the MFO for New Zealand to nominate a Force Commander for the mission. New Zealand currently has 28 personnel deployed into the MFO and acceptance of this role would require an additional mandate for three personnel (the Force Commander, an accompanying Military Assistant, and a Personal Protection Officer) from 1 December 2019 to March 2022<sup>1</sup>.

3. As the Force Commander, the candidate would exercise command over almost 1,200 military personnel from 13 different countries<sup>2</sup>, and supervise over 700 local and international civilians. New Zealand has filled this role twice in the past, including by Major General Donald McIver (1989-1991), and more recently, Major General Warren J. Whiting (2010-2013).

The New Zealand Defence Force has identified a suitable candidate for this position, who would serve for the full term of up to three years.

### *Mission Background*

5. The MFO is a neutral arbiter in monitoring the security provisions of the 1979 *Egypt-Israel Peace Treaty* (the '1979 Peace Treaty') s6(b)(i)

maintained a consistent presence in the MFO since its formation in 1982, and it is one of our most significant commitments to Middle East regional stability and the international rules-based order. In September 2018, the New Zealand Government extended the 28-person deployment to the MFO by two years, until September 2020 [CAB-18-MIN-0444 refers].

The Force Commander opportunity amplifies New Zealand's contribution to MFO

6. The position of Force Commander is currently filled by Major General Simon Stuart of Australia, who will complete his term in December 2019. [REDACTED] s6(b)(ii)

10. While the MFO mission absorbs the cost for the Force Commander, the MFO expects the contributing nation to provide two accompanying roles; those of a Military Assistant and the Personal Protection Officer. These two positions operate in closest

proximity to the Force Commander, and are traditionally from the same country due to the advantages of holding a common knowledge of language, protocol, and standard operating procedures.

#### *New Zealand's current contribution*

11. Since 1982 over 2,000 NZDF personnel have served in the MFO. New Zealand currently has 28 personnel in theatre, comprised of a driving section, a training and advisory team, headquarters staff, an electrician, and a member of the Military Police. New Zealand also contributed 33 engineers for six months in 2017 to assist in the construction of security perimeters as part of the reconfiguration process.

#### *Risks*

12. The unmitigated operational threat level for NZDF personnel deployed to the MFO s6(a) Accordingly, all NZDF personnel in theatre regularly conduct training that is relevant to the mission. s6(a)

NZDF continually monitors the operational threat level, and should the security situation deteriorate significantly, the Chief of the Defence Force, in consultation with the Minister of Defence, would take what measures are appropriate to ensure the security of NZDF personnel.

13. The proposed additional mandate of three personnel is from December 2019 to March 2022. New Zealand's 28-personnel deployment will be considered by Cabinet prior to its September 2020 mandate expiry.

#### *Implications for New Zealand's ability to deploy to our immediate region*

14. The NZDF contribution to MFO does not impact on New Zealand's ability to deploy to our immediate region in the event of an emergency. s6(a)

#### *Rotations*

15. In 2012, Cabinet agreed to the inclusion in all NZDF deployment papers of a provision that allows NZDF to temporarily exceed Cabinet-mandated personnel numbers for the purposes of command reconnaissance, rotation, and extraction of forces from theatre [CAB Min (12) 10/2 refers]. In July 2018, Cabinet noted the 2012 decision and agreed that this convention will continue [CAB 18-MIN-0346 refers]. The Chief of Defence Force will inform the Minister of Defence, Minister of Foreign Affairs and Prime Minister in advance whenever a rotation, extraction or command reconnaissance is planned above mandated numbers. s6(a)

## Consultation

16. This paper has been prepared by the Ministry of Defence, the New Zealand Defence Force and the Ministry of Foreign Affairs and Trade. The Department of the Prime Minister and Cabinet and the Treasury were consulted.

## Financial Implications

17. The estimated cost of the proposed deployment from 1 December 2019 to 31 March 2022 is \$0.505M. This is based on MFO funding the Force Commander role, and NZDF covering costs for the two additional personnel.

18. The expenditure to be funded from Crown Revenue is \$0.505M and the estimated costs can be met from the existing funding for Vote Defence Force: Operations Contributing to New Zealand's Security, Stability and Interests MCA.

19. The following table sets out the expenditure and funding arrangements for this deployment.

## Proactive Release

20. A redacted version of this Cabinet paper would be proactively released should it be approved by Cabinet, and after a decision has been made by the MFO headquarters and the Egyptian and Israeli governments to confirm or decline the New Zealand candidacy.
